Oregon Health Plan Program

Oregon Health Plan is our State's Medicaid Program. No monthly cost for insurance No out of pocket cost for covered services Eligibility for OHP is based on:

- Family income
- Household size
- Age
- Immigration status

Enrollment available year round

Eligibility requirements for OHP as adults are the same regardless if you have other health insurance.



Your Oregon Health Plan benefits



The chart below shows what benefits are available under your OHP coverage. Check with your provider or CCO to see if a specific service is covered.

Benefits covered under: OHP Plus, OHP with Limited Drug and CAWEM Plus

Chemical dependency

Dental

- Basic services including cleaning, fluoride varnish, fillings and extractions
- Urgent or immediate treatment
- Dentures
- Stainless steel crowns for molars (back teeth)
- Other crowns for pregnant women and children under age 21
- Sealants, root canals on back teeth for children under age 21

Hearing aids and hearing aid exams

Home health; private duty nursing

Hospice care - not covered for CAWEM Plus clients

Hospital care

- Emergency treatment
- Inpatient and outpatient care

Immunizations

Labor and delivery

Laboratory and X-rays

Medical care from a physician, nurse practitioner or physician assistant

Medical equipment and supplies

Medical transportation

Mental health

Physical, occupational and speech therapy

Prescription drugs

OHP with Limited Drug only includes drugs that are not covered by Medicare Part D

Vision

- Medical services
- Services to correct vision for pregnant women and children under age 21
- Glasses are covered for pregnant adults and adults who have a qualifying medical condition such as aphakia or keratoconus, or after cataract surgery.

Other benefit packages:

- CAWEM Covers emergency medical, emergency dental and emergency transport services.
- Qualified Medicare Beneficiary (QMB) Only covers Medicare premiums and copayments (except for Medicare Part D) and deductibles.

Income limits change every year in March. These limits are valid for 2020.

What Income Do I Include?

- Income received from employers
- Income received from self-employment (business income, being an independent contractor, doing odd jobs for money)
- Social Security benefits
- Unemployment
- Interest or dividends
- Any other income required to report on taxes
- NOTE: Federal law requires that AmeriCorps State and National living allowance be disregarded in determining eligibility for Federal or federally-assisted programs based on need, such as SNAP and OHP.

Who Is In My Household?

Include these people on the application:

- You
- Your legal spouse
- Your live-in partner if you have a child (under age 19) together
- Your children (under age 19) who live with you, and
- Anyone you include on your federal income tax return, including children (of any age) or a spouse, even if they don't live with you. You do not need to file taxes to get health coverage.
- If you are under 19, also include your parents, step-parents, and any siblings (under age 19) you live with

*Anyone else living with you not on this list would need to fill out a separate application.

Documents needed to apply for Oregon Health Plan

Gather documents for household members:

- Income documents i.e. Recent paystubs, selfemployment ledger, unemployment letter, Social Security benefit letter
- Social Security numbers for those applying
- Tax filing status
- Immigration documents if not US Citizen
- Information about other Health Insurance



What Happens After I Qualify for OHP

- You will be assigned to a Coordinated Care Organization (CCO)based on the County that you live in.
- The CCO will manage your physical, dental, and mental health benefits.
- Contact your CCO if you need help finding a provider or have questions about your coverage.
- You must update Oregon Health Plan about any changes from what you put on your application.
